

# Update on School Reorganization

It's been a little more than one year since the Legislature and the Governor passed the mandatory school consolidation law. In that time much has happened, including a substantial amendment to the law. Relying primarily on information posted online by the Department of Education, this article provides an overview of the status of the various reorganization plans.

In a press release dated June 20, 2008, David Connerty-Marin, a spokesman for the Department of Education (DOE), indicated that "We still anticipate coming in under 80 regional school units, as called for in the law." Using information provided on the DOE website, MMA calculates that there are currently 84 proposed RSUs, regional school units, (or exceptions) which have received preliminary DOE approval and 29 SAUs, school administrative units, whose status is either non-compliant or still pending.

The DOE information also demonstrates that the task of complying with

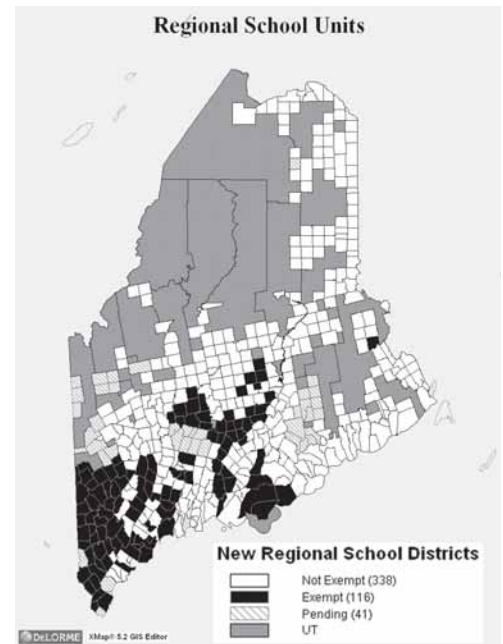
the consolidation law does not fall evenly in Maine. The smaller school systems of northern and western Maine will do most of the consolidating whereas the larger school systems of southern Maine are largely exempt. (See Map and Tables on pages 14-15). That said, the average enrollment of the 32 SAUs that have been exempted from reorganization because of their size is over 2,800 whereas the size of the 39 DOE-approved reorganizations is slightly over 2,300.

Two proposed RSUs were presented to voters in June (#37 and #38 in Table 3). The first, involving MSAD 16 (Farmingdale & Hallowell) and Monmouth, Dresden and Richmond was approved by the voters. The proposed name of the new school district is Kennebec Intra-District Schools -- KIDS RSU. The second proposed RSU was defeated -- albeit narrowly. This proposal would have combined SAD 53 (Burnham, Detroit and Pittsfield) with SAD 59 (Athens, Madi-

son, Starks and Brighton Plantation.) The voters of Madison were the only ones to reject the plan. According to the Bangor Daily News, the superintendents of SAD 53 and SAD 59 have asked the DOE for guidance.

It was expected that the majority of plans of the proposed RSUs would be presented to the voters in November, 2008. That assumption is now unclear. (see sidebar below)

Table 2 has a list of "non-compliant" or pending plans. Please note that in order to limit our map to three colors, we have included these com-



munities in this catch-all category when the status for each may be more nuanced. It appears the DOE is hopeful that some of these SAUs will ultimately agree to present a DOE-approved reorganization proposal to their voters.

*\*In Table 3, the first reorganized district - RSU 1 - in the Arrowsic area began operating on July 1. It was created by a parallel reorganization law to the one that is now governing all other school units.*

## Voting on Reorganization Plans

Only 3 of 39 reorganization plans have been submitted to the voters. It appears from the DOE website that of the remaining 36 plans, 33 have only provisional DOE approval and 3 (identified on Table 3 as #14, 22 & 36) has been given final DOE approval.

These 36 plans must be submitted to voters before the deadline of January 30, 2009. It was anticipated that most of the plans would appear on the November, 2008 ballot. However, given the time available, this is unclear.

The November election will be held on Tuesday, November, 4th. In order to comply with election laws, ballots must be finalized 45 days prior to the election -- which is approximately Friday, September 19th. So, the reorganization plans must be finally (not provisionally) approved by DOE prior to September 19th.

In its most recent round of responses to the reorganization planning committees, the DOE has set an August 15th deadline for plan submittal to DOE for its review and final approval. It is simply unclear how many of the 36 reorganization plans will be finalized by August 15 (approximately 30 days from the date this article was written).
