Act fast:

The primary focus is to ensure that the injured employee is cared for and safe.

- See to his/her immediate medical needs
- Call 911, or
- Call an ambulance to transport them to a hospital

This is a reminder that your OSHA 300A Summary of Work-Related Injuries and Illnesses for calendar year 2022 is posted in a conspicuous location or placed where employees frequent from February 1-April 30, 2023. The Loss Control Department of Maine Municipal Association receives questions year from our members about OSHA 300 logs and the posting of the 300A form.
