Ed MacDonald Safety Grant - \$3,000

Maximum Award Annually Due Date

- April 15th Purpose: The primary purpose of the Safety Grant is designed to fund equipment or items that reduce the risk of injury to workers and promote safe and healthy conditions in the workplace.

Ed MacDonald Safety Scholarship

Enrollment Purpose: The Safetv Scholarship Program is to reduce help members or eliminate employee injuries by advancing their safety or risk management skills through enhanced training.

Group Application - \$2,000 Award Group scholarship awards will be made on-site classroom training Applications will be considered that addresses areas or regional needs, provides specialized topics advances training unavailable at the local level, or will train instructors who will return to their employers to train others

Individual Application \$500 Max Award. Individual scholarships help with registration, textbooks, study materials, travel, lodging and meals.

In Your Inbox

MMA Risk Management Services has sent your Property & Casualty Pool (the P&C Pool) renewal applications. A critical coverage addressed within the application is property coverage. It's essential to ensure that your schedules are accurate and up to date to avoid any coverage gaps. Here are some steps to follow:

Review Schedules: Verify that the information matches your current property and assets. In addition, take into consideration the effects of inflation and construction costs on the replacement costs for property. Commercial construction costs have increased over 5% in the past year, and over 20% since 2020.

Make Direct Changes: If you identify anything needing changes, additions, or deletions, update the schedules directly, but please do not delete rows/columns just write in "remove" or "delete" where the change is needed.

Content Limits: When reviewing content limits by location, exclude values related to items listed on the Automobile Schedule, Inland Marine Schedule, Computers (EDP), or equipment permanently attached to the building.

Unscheduled Property: As you update your property schedules, we recommend you consider property that is easily overlooked. Examples include, but are not limited to, playground equipment, fences, sheds, picnic tables, signs, and free-standing lights.

Incorporated Fire Associations

Many municipalities recognize a volunteer fire association (VFD) as their designated firefighting unit (see 30-A M.R.S. § 3151(3)). For such VFD's, it is critically important for the municipality to confirm that the VFD is incorporated in Maine, and that the VFD's corporate status continues to be listed as in good standing.



The verification of the VFD corporate status is of importance, as a municipality may not appropriate money to an unincorporated volunteer fire department. Additionally, having an unincorporated volunteer fire department also has the potential to create a number of other unwelcome legal consequences.
